

Ontario Improving Access to Care in Peel Region

Province Increasing Investment in Hospitals to Support Patients and Families

Ontario is improving access to care in the Peel Region, helping to reduce wait times and increasing access to key services for patients and families.

Hon. Charles Sousa, MPP for Mississauga South was at the Trillium Health Partners - Mississauga Hospital to highlight the new investment. Trillium Health Partners is receiving an additional \$10 million this year to improve access to care and reduce the length of hospital stays for patients and families in the Peel region.

The recently released [2016 Ontario Economic Outlook and Fiscal Review](#) announced an additional \$140 million in funding for hospitals. This new funding is in addition to the \$345 million increase announced in the [2016 Ontario Budget](#). These new investments from the province ensure that this year, all public hospitals in Ontario receive a minimum two per cent increase to their base funding. Additional funding has been provided to hospitals to support population growth and changing health care needs in their communities.

Improving access to hospital services is part of the government's plan to build a better Ontario through its Patients First: Action Plan for Health Care, which provides patients: with faster access to the right care; better home and community care; the information they need to live healthily; and a health care system that is sustainable for generations to come.

QUICK FACTS

- Ontario is investing an additional \$140 million in public hospitals across the province to ensure that they continue to meet the growing needs of their local communities. This new funding builds on an increase of more than \$345 million for Ontario’s hospitals as part of the 2016 Budget.
- There are 147 public hospitals in Ontario.
- Hospital funding in Ontario has increased more than 2 per cent, from \$17 billion in 2013-14 to \$17.4 billion in 2016-17.
- This year’s \$51.8 billion health care budget is a 2.1 per cent increase over last year – greater than the rate of inflation.
